The test substance Alcohols, C12-14, ethoxylated, sulfates, sodium salts was found to be irritating to skin of rabbit at a dose concentration of 0.5 ml in a 24 hr exposure.

The test substance was applied to the right eye of each of 6 rabbits. The eyes of all 6 rabbits were found to show evidence of significant corneal, iris and conjunctival changes. Mean irritation scores ranged from 34.8 at 24 hours to 10.2 after 7 days. Thus suggesting that Alcohols, C12-14, ethoxylated, sulfates, sodium salts is irritating to the

In vivo LLNA study on mouse for skin sensitisation with Alcohols, C12-14, ethoxylated, sulfates, sodium salts, sulfates, sodium salts showed EC3 percentage of 11.8% this predicted value of percentage indicates that the test substance was found to be sensitizing to skin of mouse.
