

# Our approach



The social issues we've set out to tackle are too large for us alone. Along our journey we collaborated with quite a few implementation partners who helped us improve our understanding and provide solutions. We embraced the shared value approach in sustainability that looks at business solutions to stimulate social and environmental progress.



Sustainability initiatives at our manufacturing plants are driven bottom up. Our shop floor teams drive the green initiatives, and our management strategises the focus areas. We're now working with our supply chain to amplify our impact.

# **Our Good initiatives**

### **Community Development**

Along with our team members at our manufacturing sites, we address the critical need of improving education, water, sanitation and health of the local community around our sites. At GIL Chemicals, we work closely with communities across our manufacturing facilities and operations in India and directly impact lives of close to 600 people.

# **Our Good initiatives**

### Enhancing livelihoods

In Gujarat we run our flagship plant and we work closely with our neighbouring communities. Our team assessed the need of young people to skill train and enhance their income earning potential. We've run several skill training programmes such as a technical training programme for skill building for fitters, welders, machinists and plumbers. We've also run tailoring programmes for women of our neighbouring

# **Our Good initiatives**

### Public health

Around our Valia plant we partnered with the local community in Kanerao village and identified BPL families that had no access to sanitation facilities. We collaborated with the local panchayat and constructed 21 toilets at a household level that helped provide sanitation access to over 100 people. The people also contributed with community labour for the project. These toilets are now being used by the households and our team on ground also organises periodic health awareness sessions to help the village become open defecation free.



### Energy efficiency

All our processes are aligned to improve energy efficiency that helps us in our goal to reduce specific energy and in turn our overall carbon footprint. Our flagship manufacturing plant in Valia was recently certified ISO 50001:2018 (EnMS) and our Ambernath plant is under process of Responsible Care certification.



# Renewable energy

To increase our renewable energy portfolio, we utilise manufacturing by-products in energy production, use biomass briquettes, and solar energy.



### Waste and effluent management

Both our manufacturing sites at Valia and Ambernath are zero liquid discharge facilities (ZLD). We treat waste water in our water treatment plants and reuse the same in our process. We ensure a conscious use of materials and manufacturing processes that produces minimal waste. Currently, we are testing waste to energy technologies to help us manage our chemical and industrial wastes through plasma gasification process.



# Water management

We continually evaluate and implement innovative projects to reduce specific water consumption and to recycle and reuse water in our processes.



# Our Green initiatives in supply chain

### Green supplychain

Our sustainable sourcing policy applies to all our suppliers. We work closely with our critical suppliers and help them improve their sustainability performance. Till date, we have engaged and evaluated 100% of our selected critical suppliers for their sustainability performance.

We run a number of community environment initiatives across the Godrej Group



We are developing lands in the drought prone regions of Maharashtra, Telengana, Karnataka, and Madhya Pradesh. We've developed over 7,000 kectares of land and helped restore over 15 million kL of water in FY 2020-22.

In collaboration with local municipalities and social enterprises in India we are diverting waste from landfill. We process over 3,650 MT of waste annually from landfills.

In collaboration with non-profits and social enterprises, we provided decentralised, off-grid renewable energy systems through community level installations for 87 energy dark villages in India.

Our Ambernath plant was awarded a Silver rating by Ecovadis-2021 - a platform that assesses environmental and social performance along with their suppliers. With this, both our Valia and Ambernath plants are Silver rated..


GIL Chemicals has been rated "B" by Carbon disclosure project (CDP), the rating is above than the average score of C in the Chemicals sector and the global average for Climate Change. Also, for the first time we applied for Water Security at CDP Platform and have secured a rating of B which is same as the global average.

Sedex helps to manage risk and drive responsible business in global supply chains. Both of our factories are assessed based on SMETA 4.0 pillars- Labour Standards, Health and Safety, Environment, Business Ethics by a third party and are found compliant.

### Sustainable Procurement



We have developed two important policies to vouch for sustainable procurement - Sustainable Procurement Policy and Sustainable Palm Oil Policy and its Sustainable Palm Oil Action Plan. These policies highlight our expectations on critical sustainability performance parameters such as health and safety, human rights, integrity, and environmental sustainability to name a few.

### RSPO and Action of Sustainable Derivative



We are one of the leading Indian Entity to be a part of Roundtable on Sustainable Palm Oil (RSPO) and Action of Sustainable Derivatives (ASD). ASD brings together major beauty, home and personal care and other oleochemical companies and is led by BSR & Transitions to enable sustainable production and sourcing of palm oil and palm kernel oil derivatives.














# We encourage volunteering


